About this workshop

This event is organised by the OECD Higher Education Policy Team, in collaboration with the European Commission and the Finnish Ministry of Education and Culture. Together, we will explore options for building competencies for green and digital innovation through higher education. Two potential policy options will be discussed:

- - a **"widening attainment"** approach - which aims to increase the overall number of students and the throughput of degrees in the higher education system and thus achieve higher levels of educational attainment among the population. The underlying assumption of this strategy is that the advanced competencies necessary for leading green and digital innovation are nurtured through higher education.
- a **"democratisation of learning"** approach – where higher education institutions seek to transcend their traditional boundaries and build knowledge and skills across the entire society. The idea behind this approach is that everyone will need new competencies to participate in and adapt to technological and green innovation.

Finland provides an interesting national anchor for discussing these policy options, since it is simultaneously seeking to achieve higher levels of educational attainment (through its drive to substantially accelerate higher education attainment by 2030), and to further democratise learning (through its [Digivisio 2030 project](#)). The workshop will bring together national policymakers and practitioners from Finland and peer countries, along with members of the Education and Innovation Practice Community (EIPC) to discuss each of these pathways in turn.

The Education and Innovation Practice Community (EIPC)

The EIPC was launched by the OECD and the European Commission's Directorate-General for Education, Youth, Sport and Culture (Unit C.1 – *Innovation and EIT*) in 2022. Its objective is to boost dialogue and advance understanding of the competencies that help to trigger and shape innovation for the digital and green transitions, as foreseen under the [New European Innovation Agenda of the EC](#).
